- There is a \$30.00 land use fee for all riders and minders (for the entire weekend)
- Tech inspection and sign up available Friday from 3:00-5:00 PM
Saturday 8:00 AM - 8:30 AM. (All riders and minders)
- First rider out Saturday 9:00 AM
- Terrain - Granite rock & forest. Elevation 7,100-7,700 feet.
- Practice will be allowed in the designated area only.
- Awards will be presented each day.
- Spark arrestors - stamped, USFS approved, or type with proper screen size.
Custom SA must be approved at tech for installation & screen size of .023 or less.
- Youth Trial Friday, at 1:00 PM & Saturday, 2:30 PM Entry: Free (see following page)
(AMA Card required except strider class) AMA approved helmet and AMA membership is required.
- Camping is available Wednesday night to Saturday night, Max fee \$50. Overnite fee \$20.
- Camping is primitive, no power, no hookups, however RV's are welcome.
- Team parking available Wednesday, early arrivals may have to move. Space is limited!

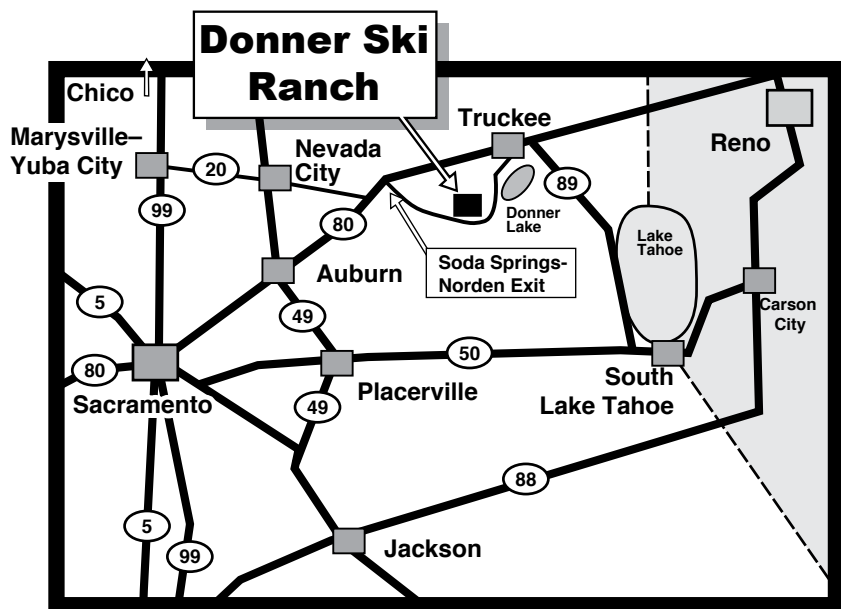
